

- 1) This offer is submitted as per current USD exchange rate and todays rate is 1USD = Rs 73.76. In case of variation above 1%, same shall be applicable in final invoice, irrespective whether it is going up or down.
- 2) For Poly Solar Cell -Average price 0.104 USD per Watt and For Mono Solar Cell- Average price 0.130 USD per Watt . Price linked to average cell price , In case of variation above 1%, same shall be applicable in final invoice, irrespective whether it is going up or down. - 3) "In case BCD or SGD or any other taxes imposed by Government of India on import of Solar Cells, same shall be applicable at actual and charged to buyer. Average Solar Cell price from www.pvinsights.com will be considered while calculating the tax part. (Formula: average cell price on mentioned link is "A" then formula will be "A x %age of BCD / SGD / tax imposed by GOI = B"). Here B will be added to final price as a tax portion."
- 4) Any delay in unloading in consignment on supply, you will be charged demurrage fees for each additional day (Rs.1500/- per 19 ft. vehicle & Rs.2500/- per 32 ft. Vehicle per night extra stay.)
- 5) Claims, if any must be informed within 24 hrs. of receipt of material and all related documents to be submitted within 07 days as per insurance company requirement. No complains will be entertain aboutshortage or transitbreakage after that.
- 6) Force Majeure: Neither Party shall be liable for failure to perform its obligations under the Agreement if such failure results from circumstances beyond such Party's reasonable control (a "Force Majeure Event"). A Force Majeure Event includes, but is not limited to, fire, flood, typhoon, earthquake, terrorism, riot, unforeseen customs delays, unavailability of materials, destruction of production facilities, labour disputes, strikes, Lockouts, Change in cost of raw material, epidemic, quarantine and other unforeseeable and unavoidable events. The affected Party will notify the other Party as soon as practicable and not later than 15 (Fifteen) days after the occurrence of a Force Majeure Event, and shall use commercially reasonable efforts to mitigate or cure the effect of the Force Majeure Event. In the event that the Force Majeure event continues for a period exceeding 3 (Three) months, then either Party may terminate this Agreement upon written notice to the other Party. Neither Party shall pay damages to the other Party for termination of this Agreement due to a Force Majeure Event.
- 7) Dispute resolution: Any difference, dispute, controversy, or claim ("Dispute") which may arise between the Parties out of or in relation to or in connection with this Agreement, or the breach, termination, effect, validity, interpretation or application of this Agreement or as to their rights, duties or liabilities hereunder, other than a Dispute for which provisions specifically made in this Agreement, shall be settled by the Parties by mutual negotiations and agreement. If, for any reason, such Dispute cannot be resolved amicably by the Parties, within 15 (Fifteen) days of the date when the dispute arisen, the same shall be settled by way of Arbitration proceedings adjudicated by a sole arbitrator appointed by the Goldi Solar Pvt. Ltd. The Arbitration proceedings shall be held in accordance with the Arbitration and Conciliation Act, 1996, or any subsequent enactment or amendment thereto. The decision of the Arbitrator(s) shall be final and binding upon the Parties. The venue of the arbitration shall be Surat. The arbitration proceedings shall be in English language. This clause shall survive termination or expiry of this Agreement.
- 8) "If after effective date there is a Change in Law which affects the Cost of Modules as well as Delivery Schedule, the price and delivery schedule shall be revised reasonably, to the extent that such party has thereby been affected in the performance of any of its obligations under this document."
- 9) "In case of a Change in Law affecting the supply Price or the Delivery Schedule, the supplier or the purchaser, as the case may be, shall provide notice to the other, of such request, setting forth the proposed amount of, and the relevant details and calculations relating to, such change in supply price. Promptly upon, and in any event within 7 (seven) business days of the supplier or the purchaser as the case may be receiving such request (such date of receipt the "Change in Law request date") the parties shall discuss such proposed change in good faith and within 14 (Fourteen) business days of the Change in Law request date, mutually agree upon a revised supply price."
- 10) Order once placed can not be cancelled. In case of cancellation 3% advanceforfeit
